
Boars Head Yard

Runs off the south side of the High Street between numbers 126 and 127.

Number 126: occupied by Robert Whenman, a carrier between 1841 and 1881; then Griffiths Bros, clothiers (1913, 1920, 1928) [tithe ref 34 in map below]

Number 127: occupied by a variety of people between 1841 and 1920, no particular trade associated with the property [tithe ref 33 in map below]

1838 Tithe Map: the numbers shown on the map were associated with the tithe apportionment and different numbers were allocated when the process of numbering the High Street took place in 1876

Boars Head Yard has ref 188a on the tithe map. 15 properties in Boars Head Yard, including two ref 183 & 184, appear to be homes (pink), the remainder of buildings (grey) are unoccupied sheds etc. The Old Workhouse is hatched, as is the Market House, perhaps denoting public buildings?

1841 Census Summary

99 people were recorded in Boars Head Yard. The names, ages (rounded down to nearest 5 years for those aged 15+ in many but not all cases) and occupations of each head of household are recorded below. The table also shows whether the head of household was born in Middlesex or not (21: Yes, 10: No), the number in each household (including the head) and a property no. showing there were 21 inhabited properties, some containing two or more households (eg Property 1).
